Evaluation Committee confirms that UB and CDA can both satisfy the RFI. They recommend to the AVCC Executive that:


Contract negotiations be opened with Ungermann Bass; if no satisfactory contract agreed between the parties then contract negotiations be opened with Control Data Australia

oversees activities of AARNet, determines matters of policy

### Proposed membership:

- 1 member of AVCC (Chair)
- 1 nominee of ARC
- •1 nominee of CSIRO
- •1 nominee of ACDP
- 3 nominees of AVCC

Of the last 4, 2 should be Directors, Computing Services and 2 should be academics

**AARNet Technical Manager and Business Manager in attendance** 

Secretary from AVCC Secretariat

Deputy Chairman to be elected from members

Expenses of the Board funded by AARNet

Board should meet regularly, suggested on a 2 to 3 monthly basis

## **AARNet Technical Advisory Panel**

### **Proposed Membership:**

- Chaired by Member of Board
- 7 other members with technical expertise and experience in computer networking

### Advises the Board on:

- Optimal directions of AARNet network architecture
- Evolving use of technology
- Provision of new and altered services on AARNet to meet user requirements
- Matters referred to it by the Board, such as, all major proposals on the technical aspects of the network

**Expenses funded by AARNet** 

Meets 3 to 4 times per year

Most business to be conducted over the network

Further expertise can be drawn upon at the discretion of the Chair

### **AARNet Management Group**

### (a) Technical Management

2 people responsible for all technical and operational management of AARNet, including:

- domestic and overseas links
- configuration of network switching equipment
- management of network services at the national level
- monitoring operational status
- coordination of response to equipment failure
- collection of usage statistics

## (b) Business Management

One person to be appointed as Business Manager responsible for

- management of budgets
- billing members
- payment of invoices
- registration of affiliates
- staff support and related matters
- secretarial support to committees

### **Regional Network Groups**

Technical-oriented group drawn from network managers at sites within the region will

- participate in the engineering work of the network
- provide regional input to the overall planning of AARNet

Management group (optional) drawn from computer centre and academic management will

- manage regional value added services within the region
- participate in regional initiatives to provide additional services
- provide responses on regional matters to the AARNet Board

Financing of these groups will be from within the region, not by AARNet central funding

### **Overall Operational Management**

į

Overall responsibilty lies with the technical section of AARNet

Assisted by hub host site personnel under a contract with the hub site

Hub site will provide facilities management of the equipment, call the service organisation and Telecom on problems

At institution sites, all equipment and interface to Ethernet provided by AARNet

A technical contact is required at each site to inform AARNet technical group and the state hub of all problems with AARNet equipment at the local site

Local sites will not have access to the AARNet equipment, any additional routing, interfacing at the local site is the responsibility of the site in locally owned and operated boxes
